## **FOREWORD**

# From the Chairperson of the Community Leaders Network of Southern Africa, Dr. Rodgers Lubilo (Zambia)

It is my duty and privilege on behalf of the CLN Executive committee, membership, and national focal persons and indeed on my behalf to present the various activities during our first year of formal existence.

Over the last year, we have demonstrated our commitment to advancing community rights and amplifying our community voices and indeed we have entrenched our presence in the global space. After operating loosely since 2019 when it was convened, CLN was officially formalized on the 22nd of October 2021. With its Chairmanship based in Zambia and its Secretariat in Namibia, and representation in 7 other Southern African Countries, CLN has grown significantly to be the lead CBNRM coordinating body in Southern Africa, ensuring that the voices of the oftenmarginalized communities are heard.

Organizationally, CLN remains a "toddler", with the office presently only having one employee operating as the Coordinator (Vilio Muunda), whilst the second is set to commence duties next Monday to assist with Finance and Administration related activities (Viona Mwanamwina). Nonetheless, they receive enormous support from the experienced members of the Network and Country Focal Persons to ensure the office is operated efficiently.

Allow me to also take this opportunity to thank NACSO for its leadership role played leading to the formalization of the network. Through, Maxi and NACSO leadership, a partnership was engaged with RASA, and RAUK and then eventually with generous support from Jamma International, we got together to rebirth the regional CBNRM dream. We further applaud Jamma International for its commitment to supporting the strengthening of the CLN secretariat and for providing us with a one-year grant.

In close collaboration with our partners and friends, "Our voices were heard" and positively influenced proceedings at the global stage (i.e CITES CoP19), continental and regional stage (APAC, AWCF), as well as nationally. We are thankful for the continued commitment from our partners, members, friends and community representatives for the unwavering support during the first year of operations; we look to strengthen these relationships further in the second year and beyond.

I should also mention that CLN is part of a global network and is currently a member of theAfrican Civil Society and Biodiversity Alliance – a Pan-African movement to support conservation in Africa. We also align our issues with SULi among other progressive groupings. We are also reaching out to SADC and will also engage AU.

## BACKGROUND

Community Leaders Network of Southern Africa (CLN) was born after the inaugural African Wildlife Summit, which was held in Victoria Falls, Zimbabwe in 2019. At this summit, community leaders noted the need to have one voice when dealing with community rights on natural resources in Southern Africa.

After the summit, the community leaders kept in constant contact with each other through various means of communication and vowed to formalise the relationships by expanding the scope and forming a network of community representatives from all over Southern Africa. in the interim, Ms Maxi Louis from Namibia was tasked to formalise the network.

Today, CLN is a voluntary association constituted under the Namibian common laws. It was formally instituted on the 22nd of October 2021 in Windhoek Namibia.

As rural communities, we are rarely involved in policymaking at international, regional and national levels that affect our rights and ultimately our livelihoods. The loudest voices against our rights are those of distant and powerful groups, far removed from our lived realities and with power and resources to influence policies that ultimately do not reflect our concerns and needs.

Without ownership of wildlife and the natural environment, we have little incentive to manage natural resources sustainably. The world must realise that we play an important role in managing ecosystems and thus our primary objective is to ensure that our voices are respected in discussions about our livelihood

### MISSION


Our mission is to strengthen national community-based natural resource management programmes such that Southern African local communities influence policies and decisions that affect their livelihoods at all levels of governance.

# **BACKGROUND: STRUCTURE**




The assembly of community representatives from all our member countries is the highest level of decision-making in CLN. In order to harness the wide range of expertise from all over southern Africa, country representatives work closely with the secretariat team to ensure efficient operations.

The CLN team is a tight-knit, experienced group with a shared vision of amplifying the voices of community members from all over Southern Africa. Dr Rodgers Lubilo of Zambia is the chairperson of cln; Mr Charles Jonga of zimbabwe is the vice-chairperson; whilst Mr siyoka Simasiku of Bostwana is the treasurer. With the CLN Secretariat office based in Namibia, Mr Vilio Muunda serves as the Coordinator, under the daily guidance of Ms Maxi Pia Louis – the CLN Secretary. member countries such as Tanzania (Mr Mohamedi Kamuna), Malawi (Mr Malidadi Langa), and Mozambique (Mr Jose Monteiro) are also represented on the executive committee of cln. The team is fast expanding, recently securing the services of a Finance and Admin Assistant (to officially commence in early December), meanwhile, a financial consultant has been contracted to ensure sound financial controls.


- 1) 08 December 2021 Introduction of the new CLN Executive Committee elected at the "CLN Namibia Workshop", October 2021.

# OTHER ACTIVITIES FOR 2021/2022

## **Nsefu Bio-cultural Community Protocol**

Bio-cultural Community Protocols (BCPs) articulates community-determined values, procedures and priorities, and sets out community's rights and responsibilities under customary, state and international law. It is developed after a community undertakes a consultative process to outline their core ecological, cultural and spiritual values and customary laws relating to their traditional knowledge and resources, based on which they provide clear terms and conditions to regulate access to their knowledge and resources.

Prior to broader rolling out of the programme, a pilot BCP has been initiated in Zambia's Nsefu Village Action Group (VAG) in September 2022, in collaboration with Resources Africa. The BCP of the Nsefu VAG provides an insight into important social and cultural values of our people. It highlights and documents their traditional knowledge, way of life, customary laws. It also identifies current challenges faced and their impact on our way of life. It documents and showcases community's role in protecting and conserving biodiversity, and states clear terms and conditions regulating access to their knowledge and resources. By developing the BCP, the Nsefu community call on the Zambian Government and other stakeholders to recognize and appreciate our vital role as guardians and conservators of biological diversity and recognize our customary and legal rights over our land, territories and natural resources. We are hopeful and confident that the rollout of subsequent BCPs throughout southern Africa will fllow same successful trajectory.

# Monitoring and Evaluation in Southern Africa

Through the "Voices of the People" project with Resources Africa, five (5) Monitoring and Information Officers have been hired in Botswana, Malawi, Tanzania, Zambia and Zimbabwe, with the primary objective of cataloguing the communities practicing CBNRM in their respective countries. The data collected included the number of households, etc. as well the geolocation of these households. The data will be used to create a database of CBNRM related activities in Southern Africa, which will be used as an effective adaptive management tool.



Viona Mwanawina: The new CLN Finance and Admin Assistant

The CLN Treasury is headed from Botswana by the Executive Director of the Ngamiland Council of NGOs (NCONGO), Mr Siyoka Simasiku. Since the opening of the CLN Bank account in February, the Treasurer did not have access to the account because the bank requires that the addition of any signatory should be done physically. After securing the Jamma grant, it was planned that, as a matter of urgency, the Treasurer visits Namibia to be added as a signatory (10 - 12 August 2022) - in this way, he will have more financial oversight of the organisation.

The visit also served as an opportunity for the Treasurer to meet with the financial consultant (Peggy and Co Ltd) who will be temporarily tasked with setting financial management systems within CLN, as well as loading all transactions to trial balance. To date, the CLN accounts are updated, with continuous improvements still a necessity. With sustainability in mind, we are in the process of finalizing the financial operation guidelines as well as finalising the recruitment of a Finance and Admin Assistant who will initially work with, and later take over from, the financial consultant.

## INTERNATIONAL ADVOCACY

As communities from Southern Africa, we have noted concern about the recent increase in opposition to sustainable use of natural resources, including attempts by the global north to ban the importation of hunted trophies from Africa. Southern African communities have long demonstrated their ability to conserve wildlife through Community Based Natural Resources Management (CBNRM), through which regulated sustainable use is permitted.

In partnership with Resource Africa (South Africa and United Kingdom offices), we have consistently scanned the political and media environment throughout the world for attempts of advancing the "anti"-sustainable use agenda and any other developments that may affect the livelihoods of our communities. In response, CLN timely contacted several government representatives and NGOs, offering an opportunity for consideration of the perspectives of the affected rural communities. Thus far, we have written letters to the following groups:
